

SAP EH&S Dangerous Goods Management with integration to Sales & Distribution

Sales and distribution of products classified as dangerous goods is subject to a large number of regulatory restrictions. The compliance with those restrictions can proof very resource intensive. SAP EH&S Dangerous Goods Management allows assigning of all necessary dangerous goods information required by regulations worldwide for any possible mode of transport to your products and raw materials. The compliance with dangerous goods regulations can be monitored via specific dangerous goods checks, realized directly in the Sales & Distribution module - starting with the creation of a sales order all the way to picking of your delivery and printing of the delivery note.

SAP EH&S Hazardous Substance Management

Manage the hazardous substances produced or occurring in your production with SAP EH&S.

The component Hazardous Substance Management allows meeting all functional and regulatory requirements.
